HAVE YOU CONSIDERED ARRANGING A LASTING POWER OF ATTORNEY (LPA)?

- Why should you

At present you may be feeling fit and healthy and do not consider the need for an LPA. However, consider the day when you may lose Mental Capacity i.e. suffer from dementia, Alzheimer's or any other debilitating disease that restricts your ability to control your own affairs. Who will make decisions for you if you lose that capacity? Bear in mind an LPA can only be arranged if you have mental capacity.

Under an LPA you appoint attorneys, most likely members of the family, and then they can make decisions on your behalf. It is important to note that when you complete the applications for an LPA you have the opportunity to express your own wishes in respect of how you would wish your attorneys to handle your affairs.

There are 2 types of LPA

LPA Financial Decisions

Under an LPA for Financial Decisions your attorneys can make decisions such as:

- Arranging repairs to your home
- Paying your mortgage and bills
- Accessing bank and investment details
- Selling your home

LPA Health and Welfare

If you create this LPA your attorneys can make decisions such as:

- Your medical treatment
- Where you live
- Care and support you receive
- Life saving treatment

While you don't need a solicitor you may decide that a solicitor is the appropriate person to complete your application especially if you have complex affairs.

Alternatively, you could go to the Office of Public Guardian (OPG) website:

www.gov.uk/lasting- power-of-attorney or call 0300 456 0300. If you are happy to, you can complete the forms yourself. The OPG provides you with guidance on their website. The fee is \pounds 82 for each LPA giving a total of \pounds 164.

Once you have completed the application form it will need to be signed by a certificate provider i.e. someone who has known you for at least 2 years (not a family member) or your GP, solicitor or social worker. The application will also require the signatures of the attorney(s) who should always act in your best interests. Once the form is fully completed it will need to be registered with the Office of Public Guardian by post. Your LPA cannot be used until registration is completed, which can take several weeks.

In the event of your death the LPA ceases on the date of death therefore it is most important that your Will is up to date as this replaces the LPA.
