## **Funeral Support Guide**

Naval funerals are steeped in ceremonial traditions, including the dressing of the coffin, the procession, the role of the Standard bearer, the Last Post and Reveille and “Piping the side” on the Boatswain Call.

The Royal Naval Association is here to support families in providing support and guidance to ensure a dignified and fitting tribute to mark the passing of a Shipmate. It is important to us, that the support we offer reflect the wishes of the deceased’s family.

Our compassion and care to the family extends beyond the funeral; through our Branches we are here to offer support to the families and shipmates of those who have passed away in the days and weeks that follow.

Many families may not be aware of the length of service or where indeed their loved one served. The Next of kin may apply for the Service records.

### **Liaison with Funeral Directors**

It will be important that people understand the requirements of the family, so a good relationship with the funeral directors is crucial. The RNA can assist with any specific Naval information you would like to give to your funeral director.

### **Coffin Drape**

The Royal Naval Association (RNA) may be able to assist with the provision of coffin drapes, flags, or ensigns, where appropriate.

In the case of a veteran, it is permissible—upon formal request—for the coffin to be draped with the White Ensign as a mark of honour and respect. As veterans do not fall within the scope of King's Regulations, this practice is considered a dignified and appropriate tribute to their service.

In accordance with King's Regulations, the coffin of a currently serving member of the Armed Forces is to be draped with the Union Flag. These regulations apply solely to individuals in active service.

### **Dressing the coffin**

Wreath / Flowers, Caps / Berets, Swords, may be placed on the coffin.

### **Medals**

A family member may wish to carry the deceased Medals; this is always a nice touch; a cushion would be recommended to place the medals on.

If family believe the deceased has medals but cannot find them an application maybe made via this link.

### **Standard Bearers (SB)**

Again, depending on the family's requirements a SB may attend a funeral to represent Naval Associations that the deceased belonged to, or local RBL Standards can be invited to attend. Once again, we suggest liaising with the whole family to ensure everyone is happy.

The RNA does not offer Coffin Bearers. This be undertaken by the Family or Funeral directors.



## **Piping Side Party**

Someone with a Boatswain's Call may be available to "Pipe the side" & "Carry On."

## **Bugler**

A Royal Marine Bugler may be available but not guaranteed. The RM Bugler maybe available to those shipmates who has completed full pensionable service or been awarded an operational service medal is entitled to a Bugler at public expense, subject to approval by the Single Service Tasking Authority for the RMBS. ## **Piper**

If the deceased was of Scottish decent, a Piper may be considered. The Piper may play and march in front of the hearse and may play a Lament at the funeral service. But again, we suggest liaising with the family and the funeral director.

## **Burial at sea - England**

A Burial at sea is something that the deceased has requested.

A burial at sea is the process in which human remains are committed to the sea as a final resting place.

A marine licence is required from the Marine Management Organisation (MMO) for a burial at sea in English waters or Northern Irish offshore waters.

For England -There are three designated burials at sea locations, which are:

Off The Needles, Isle of Wight

Between Hastings and Newhaven

Off Tynemouth, North Tyneside

### **Burial at sea - Wales**

Natural Resource Wales for burials at sea in inshore and offshore areas of Welsh waters.

### **Burial at sea – Northern Island**

The Department of Agriculture, Environment and Rural Affairs, for burials at sea in inshore Northern Irish waters; and

### **Burial at sea - Scotland**

The Burial, Cremation and Death Certification Team, for burials at sea in Scottish waters.
