RBL's Campaigns, Policy and Research (CPR) team hosted over 60 MPs and Peers at the Speaker's Apartment in January. MPs heard more about the needs and experiences of the Armed Forces community in the UK, and the work RBL does to support them.

Speakers included the Speaker of the House of Commons, The Rt Hon Sir Lindsay Hoyle MP; Minister for Veterans and People, Al Carns OBE MC MP; and RBL National Chair, Jason Coward. Gemma Barnes, vice-captain of RBL's Team UK, shared her inspiring recovery journey. The event reinforced the need for continued collaboration to ensure the Armed Forces community's voices are heard.

RBL's Director General addresses the Defence Select Committee

Mark Atkinson, RBL Director General, appeared before the <u>Defence Select</u> <u>Committee</u> earlier this month to discuss how the Armed Forces Covenant can better support veterans, service members, and their families. His testimony was part of a wider review of the Covenant's effectiveness, impact and future after the Government promised to strengthen the Covenant Duty in their election manifesto.

Mark gave evidence alongside Lieutenant General (Rtd) Sir Nick Pope, Executive Chair of the Confederation of Service Charities (Cobseo), to the Committee, a cross-party group of MPs, chaired by Tan Singh Desai MP.
