#### How to Enter:

- 1. Once the form is live, visit our website and follow the instructions to register for the ballot: <u>Festival of Remembrance | Royal British Legion</u>
- 2. You will need your membership number to complete your ballot entry.
  - Your membership number can be found on your membership card or on your renewal letter reminder.
- 3. Each member is allowed to enter the ballot once, for a maximum of two tickets.

#### Next Steps:

- If you are successful, you will receive an email with a unique link from Thursday 10 July 2025 onwards. You will then be able to select your seats in your preferred location (subject to availability) and will be asked to enter your guest information and payment details.
- Payment must be completed within seven days of the link being sent.

## Behind the scenes at Annual Conference

When RBL colleagues came together for Annual Conference 2025, there was one mission: to look after our members. So, it was a rewarding sight to see delegates and visitors leaving with smiles.



Preparations began more than a year ago and it was with great anticipation that colleagues from across RBL descended upon Harrogate. Briefings were had, goody bags were packed – and one of our dedicated MEOs, Sharon Turton, even

volunteered to drive a truck so that a dais for our parade could be collected from Imphal Barracks, York.

Radios, WhatsApp Groups and Teams chats kept everyone in the loop so that issues could be dealt with quickly – including, for instance, "Where is Ruth?!" This was when our new Interim Director of Membership, Ruth Efunnuga, had – unbeknown to her – won first runner up for the Sir Clive Johnstone award and we had to get her into the auditorium on time.

Volunteering behind the scenes at Annual Conference is a privilege, especially if we might get to witness a special moment such as the National President receiving his jewel of office, followed by the National President surprising Devon County Chair Yasmin Gibbins with a gold badge and

Cornwall County Parade Marshal, Tony Vidler, with Life Membership.

From shedding a few happy tears to sharing laughs, there was also the Women's Section (WS) forum in which the WS National Chair, Jan Buxton, said she would make Executive Directors Antony Baines (Services) and Gary Ryan (Marketing, Fundraising and Remembrance) honorary WS members – just before presenting Antony with a cheque for £150k to refurbish the family rooms in RBL's care homes and promising to make up any shortfall on funds for new televisions in the homes.

Many queries answered, boxes unpacked and repacked, several thousand steps taken, assistance given, feedback gladly taken – these are just a few of the activities that go on behind the scenes.

And with last box labelled and ready for collection, the conversation turned to Brighton and <u>Annual</u> <u>Conference 2026</u>, 8 – 10 May. Will we see you there?

### Strengthening the Armed Forces Covenant Duty

The Royal British Legion recently supported the latest meeting of the <u>All-Party Parliamentary Group</u> (<u>APPG</u>) on the <u>Armed Forces Community</u>, focusing on how the Armed Forces Covenant Duty is being applied and where improvements are needed.

The <u>Armed Forces Covenant</u> outlines the nation's obligation that members of the Armed Forces, veterans and their families should not face any disadvantage due to their service, and provides special consideration in certain circumstances, such as for those who have been injured or bereaved.

With gaps in implementation reported in many areas of the country and key policy areas such as employment and social care still excluded, we're continuing to call for the Covenant Duty to be strengthened.

This work feeds into the shaping the upcoming Armed Forces Bill, which is expected to expand the Duty's scope.

### Marking 80 years since VE Day

From coffee mornings to dancing in the streets, last month our branches worked tirelessly to make sure VE Day 80 received the recognition it deserved. Here are just a few highlights of the tremendous work that connected communities with their local branches.

In addition to flag raisings, a lunchtime service and linking in with local entertainers to put on an evening event, **Redcar Branch**, North Yorkshire, created a poignant display by lighting 226 tealights – one for each of the names on the local cenotaph and for the civilians who lost their lives during bombing raids on the town.



**Burbage Branch**, Leicestershire, assisted Burbage Heritage Group in creating a temporary history trail. Branch members approached the occupants of houses linked to men who had lost their lives during WWII, seeking permission to display a poster with a QR code outside the house, telling the men's stories. Five posters that couldn't be placed – two addresses no longer existed – were displayed in the rose garden of the village war memorial.

**East Preston and Kingston Branch**, Lancashire, invited a Winston Churchill impersonator to get the crowd into street party mood. With huge support from the local community, the East Preston RBL



Club, where the event was held, was at capacity inside and out for the whole day. An opera singer, Harriet Rose, and a trio of 'wartime singers', The Silhouettes, provided the entertainment while 'Winston Churchill' mingled with the crowds

**Nantwich & District Branch,** Cheshire, sent thanks to RBL for the VE Day grant, which helped them to <u>bring the local community together</u> in an event where "there was literally dancing in the streets". A tea party also proved to be a success, helping to promote RBL in the community and raising £904.95 for the Poppy Appeal.

Meanwhile members at **East Knoyle Branch**, Wiltshire, were joined by communities from other parishes for a service of Remembrance that was followed by a celebratory buffet in a decorated marquee and a quiz on WWII rationing.

In Cambridgeshire, **Wisbech Branch** marked the day by <u>signing up its latest member</u> – WWII veteran, 102-year-old Stanley Eastgate. Mr Eastgate had requested to join the RBL. A Wisbech man, he completed his National Service from 1942 to 1947. The branch was contacted by Mr Eastgate's

son and daughter who enquired whether their father was too old at 102 years to join the RBL.

After Toby North, Chair of Wisbech Branch, explained that you are never too old to become a member and that the branch would be delighted for Mr Eastgate to join, it was agreed that he would become a member on VE Day



80. Toby said that the Wisbech Branch is 103 years old and one of the first branches in the country to be consecrated in 1922; also that Stanley may be the oldest person ever to become a member for the first time at 102 years old.

In Leicestershire, **Melton Mowbray Branch** marked the day with residents of Wilton Manor Care Home, along with invited guests from RAFA Association. As well as a lovely afternoon tea, there was a 1940's singalong that was enjoyed by all.

Still in Leicestershire, **Hinkley Branch** linked with the Head Teacher and Governor of a local primary school to mark the day. Fabulous aerial photographs were taken of pupils dressed in red, white and blue to form a large 'VE' and military vehicles and re-enactors also attended to bring a bit of the 1940s to the school.

At their touchpoint and branch office, **Weston-super-mare Branch** marked the day with a street party-themed coffee morning, which was attended by local veterans, the town Mayor and local supporters – also helping the branch's most senior member to celebrate his 93<sup>rd</sup> birthday!

Finally, in Lancashire, an estimated 25,000 people attended 'VE80 Fest' – a free, open air concert and family-friendly day organised and hosted by **Blackburn Branch**. Aimed at bringing local communities together, the event was over seven months in the planning and widely advertised both on social media and local newspapers.
